**IT IS AGREED AS FOLLOWS:**

1. The User acknowledges have reading and fully understanding the attached Terms and Conditions and the present Form (collectively referred to as "the Documents" and their implications. The User hereby adheres to the Documents and applies for being granted a right to Use the Data in accordance with the Documents, for one of the following purposes:

- the management of an inventory of Audiovisual Works, for user's own internal purposes;
- the proper execution of a filtering software, of a digital rights management software or of another software aiming at the identification and selection of Audiovisual Works for preventing harmful or infringing content or for controlling the use of said Works;
- the search and selection of Audiovisual Works within the framework of the commercial distribution of such works to End-users;
- the provision of statistical reports to End-users on the production, the publishing, the broadcasting and other operations pertaining to Audiovisual Works;
- the provision of information (which incidentally includes whole or part of the Data) pertaining to a particular Audiovisual Work or to a set of such particular works, within the framework of a TV guide, an electronic program guide or any other information service of such kind delivered to End-users;

2. The present Agreement covers the usage period from \_\_\_\_\_ to \_\_\_\_\_ . Thereafter, it shall be automatically renewed for successive periods of one year, unless terminated by either party by giving 3 months written notice through a registered letter prior to the end of the renewal term.

3. Subject to the payment of the Fee to RA, and subject to the attached Terms and Conditions, the User is hereby granted the right of:

- Consulting the ISAN for internal purposes ;
- Consulting the ISAN and the Descriptive Information for internal purposes;
- Storing the ISAN on any physical medium other than the ISAN System for internal purpose, otherwise than as the result of the temporary reproduction necessary for the mere extraction via electronic means;
- Storing the ISAN and the Descriptive Information on any physical medium other than the ISAN System for internal purpose, otherwise than as the result of the temporary reproduction necessary for the mere extraction via electronic means;

4. The Use of the Data is subject to the payment of the Fee set as a monthly fee of \_\_\_\_\_ (currency). The Fee is subject to change after the initial term, under a three months notice period prior to any renewal period.
